Ambassador's Agreement

This Ambassador agreement is made _____, 2013 by and between Citizens for Affordable Energy, Inc. and (Name of individual) (Individual's location address).

Citizens for Affordable Energy is a non-profit, non-partisan charitable organization that educates citizens and promotes public policy efforts to make energy affordable and sustainable through education outreach regarding the Four Mores:

1. **More energy** from all sources,
2. **More technology** for efficiency,
3. **More environmental protection**, and
4. **More infrastructure**.

Ambassador desires to be associated with Citizens for Affordable Energy and to help educate/engage citizens in their community on the Four Mores and related energy solutions using materials and information provided by Citizens for Affordable Energy, and local information as appropriate, approved by Citizens for Affordable Energy. Citizens for Affordable Energy and Ambassador agree, as follows:

- a. Citizens for Affordable Energy will provide educational materials and information to Ambassador to educate citizens in their community. Ambassador will not use any materials other than those provided by, or approved in advance by, Citizens for Affordable Energy to pursue their mutual goal of educating citizens.
- b. Citizens for Affordable energy will provide ongoing information updates through its website for Ambassador's use.
- c. Ambassador is not permitted to use the name or logo of Citizens for Affordable Energy for any purpose other than education outreach unless they obtain approval from Citizens for Affordable Energy.
- d. Ambassador is not permitted to contact government officials to lobby on behalf of or in the name of Citizens for Affordable Energy. Government official contacts must be limited to information or education exchange only. In addition, Ambassador is not permitted to engage in any political activities, such as endorsing candidates for elected office, supporting or opposing ballot initiatives, or advocating for or against specific legislation in the name of, or on behalf of, Citizens for Affordable Energy.
- e. Ambassador is prohibited from incurring any liability, obligation, expense (other than minimal self-paid expenses incurred in normal education outreach), or entering into any agreements with any third party on behalf of or in the name of Citizens for Affordable Energy.
- f. Ambassador may recruit individuals for Citizens for Affordable Energy and other volunteer Ambassadors.

- g. Ambassadors may not solicit funds, including membership dues payments, for Citizens for Affordable Energy. Voluntary donations, less documented personal expenditures as occur in education outreach, if offered and paid, are payable only to Citizens for Affordable Energy.
- h. Citizens for Affordable Energy and Ambassador may terminate this agreement at any time. Upon termination, Ambassador is prohibited from using the name or logo of Citizens for Affordable Energy for any purpose.
